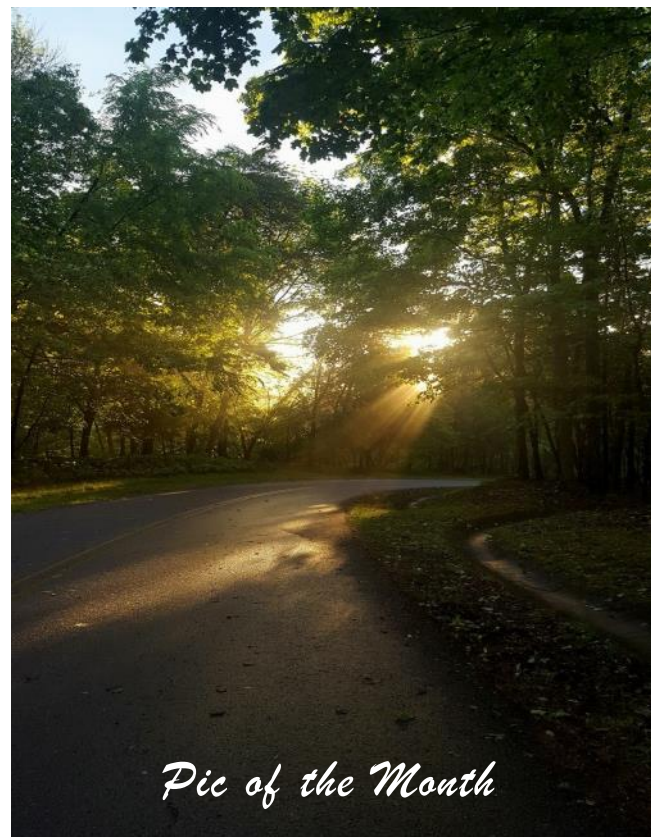

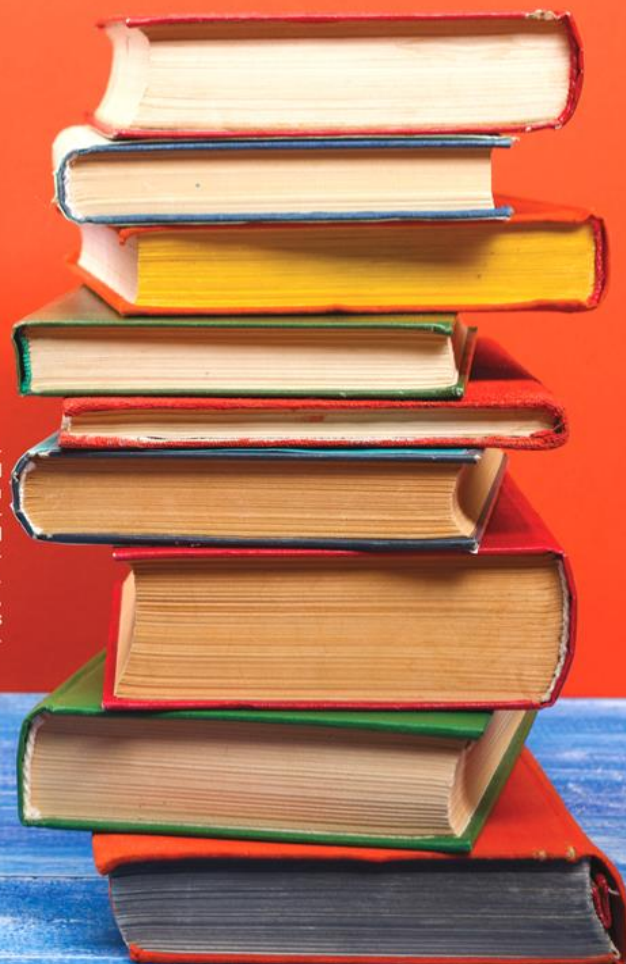

## Small Business Marketing: Focus



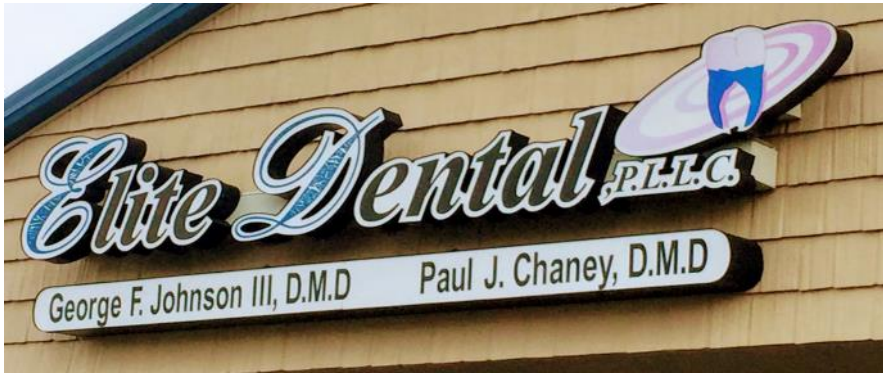
Visibility is a very important aspect of marketing that will never change—regardless of the year, social setting or business. Marketing before and after a digital transformation revolves around how customers see your business. We certainly do not have all the answers but we do have some insights on where to begin.

It begins with one simple word — FOCUS! With the trend the last few years being on data, it is easier than ever to identify your target audience. This can be misleading at times, however, as discerning valuable information from the volume of data can be overwhelming. How do we stay focused and create more product conversions? It is a difficult question but there are some basic truths that will always be evident. Here are 3 simple rules to staying focused in your marketing strategy:

1. **Focus on creating a customer experience**— Customer experiences are the heart of any marketing campaign. While it has always been an important focal point, today's businesses, at least the most successful ones, have embraced a "Customer First" philosophy to create effective marketing strategies. A satisfied customer can be your biggest ally. Make it personal and don't let creativity get in the way of delivering a good customer experience.
2. **Focus on consistency**— Consistency in message is an absolute must. If your message, including your materials, are not consistent, it may leave your audience with their heads spinning. Pull out all of your marketing materials over a six-month period and lay them out on a table. See how many of them are similar. If you have trouble with this exercise, you may need to seriously consider a branding facelift. Start with primary colors and fonts. This alone can make a huge difference.
3. **Focus on the WHY**— Every successful marketing campaign **must** begin with determining the why. It doesn't matter how great your product or service is if you cannot get your audience to feel the same as you do about it. A wise friend of mine once said that in order to trust something you must first believe in it. If you believe in your product, tell others why!

So, when you begin developing your next marketing strategy, start with the basics. If you can keep these few things in mind, it will help you to establish a clear market direction going forward. Take a deep breath, slow down and make it **MATTER!**

## Glenmore Mansion Seeking Support Letter to Partner with MTSU

DANDRIDGE, TN – MAY 15, 2017 – Glenmore Mansion Board of Directors is making application for one of five Partnerships for Professional Service Awards available through the Center for Historic Preservation at Middle Tennessee State University.

Along with our application we need several letters of support from local governmental officials and other community stakeholders. **We are asking that you write a brief letter giving your support for our efforts to secure this award.**

In brief, this award will not provide any monetary support for Glenmore Mansion, but makes available the Center for Historic Preservation professional services at no charge. Thus, we gain the expertise provided by faculty and staff, assisted by MTSU public history graduate students who are training at the center.

Their guidance and expertise would help Glenmore plan for a professionally designed “Exhibit Room” that will become a part of the walking tour, thus enriching our visitor’s experience. We would be converting the current “Gift Shop” rooms into an exhibit space. Numerous options for exhibits are possible, but we’d like to highlight local history that currently has no exhibit venue in the county.

**For Example.....**

- The **Civil War Battle of Mossy Creek** which took place primarily on Branner land.
- The **East Tennessee and Virginia Railroad**; John R. Branner’s role in bringing the railroad to Mossy Creek and his time as President of the railroad.
